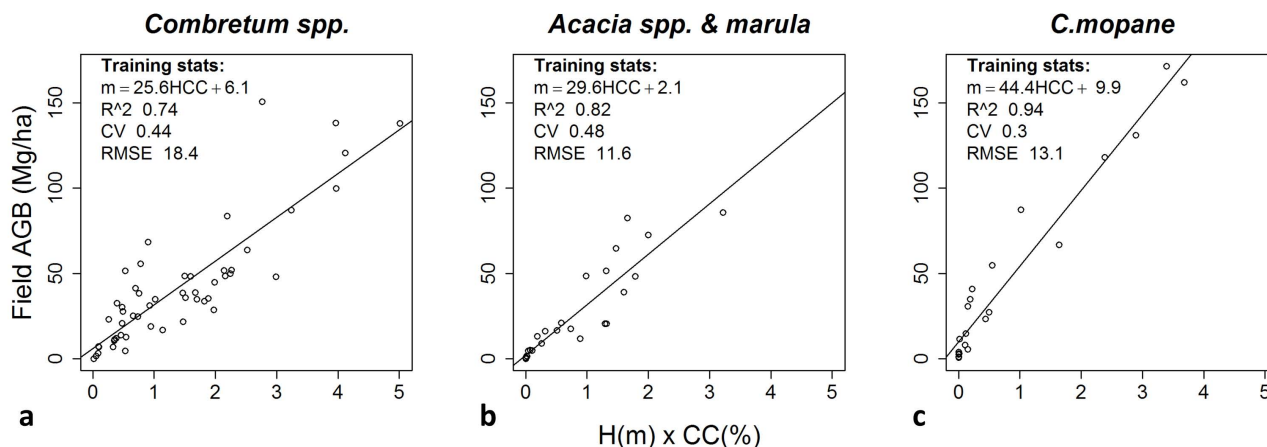


Fig. 2. Model calibration to predict AGB using airborne LiDAR. Points represent calibration field plots. Three models were trained according to dominant woody species: (a) mixed broadleaf (*Combretum apiculatum*, *Combretum collinum*) and fineleaf (*Acacia nigrescens*, *Dichrostachys cinerea*) savanna, (b) *Acacia* spp. and marula (*Sclerocarya birrea*) savanna, and (c) mopane (*Colophospermum mopane*) savanna.
